If your chapter has had a member death this past year (since the virtual 2021 KSO convention), you will need to fill this form out. These forms are what allows us to remember our sisters during the "Celebration of Life" during the State Convention. If you are not sure where to find Form 6, go to the DKG International website, sign in, click on "Forms." Once you are in the "Forms" section, click on "Membership" and Form 6 is the first membership form listed. When you have filled the form, send KSO Treasurer Shelia Wilkinson, DKG International, and myself a copy. In order to be remembered during the KSO 2022 Convention, I need any death notifications by February 15 that have not been sent to me previously. And as a reminder, if DKG International receives the notification within three

months of the member's death, they will send a close relative or close friend a sympathy card.

We will also be recognizing KSO members who are celebrating 40, 50, and/or 60 years membership during the State Convention. These will be sisters who were inducted in the years 1982, 1972, and 1962. I hope that I will be able to see many smiling faces and that there will be hugs given everywhere during our convention while we honor our longtime members and our former sisters!

What is State Convention? Our state convention's main purpose is to hold our annual business meeting. It is also a time for members to network, see old friends, make new friends, and learn more about our society. There is a marketplace at which chapters can rent a table and sell products to earn money for chapter projects/programs/scholarships for examples.

What is the Birthday Luncheon? Many chapters also have an annual birthday luncheon. This is a time we celebrate our Founders and honor the years we have been in existence. Kentucky's birthday into DKG was March 24, 1937. We were the 25<sup>th</sup> state to join DKG and the first two chapters were Alpha and Beta. Our first state president was Founder Dr. Ethel Parker (Beta). This year we are 85 years young!

What is the President's Banquet? This is a more formal dinner in the evening where wonderful memories can be made. Hall of Fame Inductees are announced at this banquet and on the odd years, we install the new state officers. Past State Presidents and Chapter Presidents march in at the beginning of the banquet and we usually ask that if a president cannot make the banquet, that someone attends in her place. We would like for all chapters to be represented in the march; however, with the pandemic still with us, we understand if some chapters may not be represented and that not all presidents may be able to attend. Most ladies love to dress up with some place to go and this is the place to dress up and go! This dinner is not just for chapter presidents – it is for any member and/or guest who chooses to attend.

What is the White Rose Ceremony? This ceremony is actually a memorial service at which any of our deceased members in the past year are honored and remembered. A white rose in her memory is placed among the red – signifying that her memory will live on within our hearts.

**So, what happens on Friday?** In years past, a variety of things have happened on Friday. We plan something for those who need to travel a distance and wish to arrive the evening before. We have had karaoke, craft fun, fun with word games, and more. The pandemic makes us change things up a bit to keep us all safe. This year we have a hospitality room. We will wear masks and *To Go Bags* with snacks will be available for attendees to take to their rooms.

What is the attire for convention – what do I wear? Friday night is come as you are and comfortable from travel. Saturday Business Meeting, Birthday Luncheon, and Sunday White Rose Ceremony are business casual. The President's Banquet is more formal, and some members wear long gowns while others wear short dressy dresses and some don nice pant outfits that are made for more formal occasions. Please do not feel that you must go out and purchase an outfit to attend. Simply dress up a bit more than usual as if you are going out to a special dinner.

Re: Amendment to the Kentucky State Organization Bylaws and Standing Rules

Date: February 6, 2022

The Rules Committee proposes the following amendment to the *Kentucky State Organization Bylaws and Standing Rules* -- Combine the positions of Recording and Corresponding Secretaries into one position of Secretary. Rationale – electronic communication has altered the duties of the Corresponding Secretary in such a way that written communications are rarely received thus rendering that position a name only position. In addition, finding members to hold an office has become more difficult.

### ARTICLE VI — OFFICERS AND RELATED PERSONNEL

### **Currently Reads:**

### Section 1. State Officers

A. The state officers shall be a president, a first vice president, a second vice president, a recording secretary, a corresponding secretary (all elected), and a treasurer (appointed by the Executive Board). The state Executive Board may, at its discretion, appoint a state executive secretary.

# Section 2. Duties of Officers and Related Personnel

### E. The recording secretary shall:

- 1. record in writing the minutes of all Executive Board meetings;
- 2. will call and record the roll at the general session;
- 3. will distribute the typed minutes to The State Organization News editor for publication in the Kentucky State Organization News thirty (30) days prior to the next State Organization meeting;
- 4. maintain and file the minutes after each meeting in a book of minutes for future reference. (2020)

### F. The corresponding secretary shall:

- 1. receive and respond to all Executive Board correspondence as appropriate to the method of such correspondence;
- 2. maintain a record of correspondence and communications with the Executive Board;
- 3. read correspondence as received by the Executive Board at its Annual meeting;
- 4. serve as chair of the State Organization Communications Committee. (2020)

#### As Amended

### **Section 1. State Officers**

A. The state officers shall be a president, a first vice president, a second vice president, a secretary (all elected), and a treasurer (appointed by the Executive Board). The state Executive Board may, at its discretion, appoint a state executive secretary.

# Section 2. Duties of Officers and Related Personnel

### E. The secretary shall:

- 1. record in writing the minutes of all Executive Board meetings;
- 2. will call and record the roll at the general session;
- 3. will distribute the typed minutes to The State Organization News editor for publication in the Kentucky State Organization News thirty (30) days prior to the next State Organization meeting;
- 4. maintain and file the minutes after each meeting in a book of minutes for future reference. (2022)
- 5. receive and respond to all Executive Board correspondence as appropriate to the method of such correspondence;
- 6. maintain a record of correspondence and communications with the Executive Board;
- 7. read correspondence as received by the Executive Board at its Annual meeting;
- 8. serve as chair of the State Organization Communications Committee. (2022)

### **Call to Order**

The General Session of the State Convention of Delta Kappa Gamma Society International, Kentucky State Organization, was called to order at 9:30 EST, on March 20, 2021, by KSO President, **Beth Pyle** (Delta). An Inspirational Thought was delivered by **Misty Wills**, Delta Chapter President. The Welcome was given by **Mary Evans**, Convention Co-Chair (Delta). Response to Welcome was given by **Lucy Riffle**, KSO 2<sup>nd</sup> Vice-President (Zeta). Introductions were given by President Beth Pyle (Delta), and included **KSO Officers and Lace Marie Brogden**, International Guest

Roll call was read KSO Recording Secretary, Mary Cat Flath (Epsilon). Six state officers, seven past state presidents, and eighteen-chapter presidents or their representatives were present, constituting a quorum.

Minutes of the 2019 KSO Convention were presented in the Convention Book of Reports. They will stand approved as read.

Donna also thanked her members for their hard work, which focused on assisting chapters in revising their current Bylaws and Standing Rules. Ramona Jeffries (Mu) updated the membership that KSO President will be a voting member of the Rules Committee, versus ex-officio member moving forward, accordingly to newly revised Robert's Rules of Order, 12<sup>th</sup> edition.

Scholarship submitted a committee report to the Convention Book of Reports.

World Fellowship-Bonnye Roof (Omega), submitted a committee report to the Convention Book of Reports.

### **Individual Reports**

US Forum- Ramona Jeffries (Mu), submitted a committee report to the Convention Book of Reports. It was also reported that there was no forum in 2020, however 2021 meeting is scheduled for March 6-8, in Washington D.C. It was announced that all paid DKG members are part of the forum and can attend the event. Lucy Riffle noted that the event is outstanding and worth attending, if possible.

She also reported the highlights of pre-Covid and post-Covid events; she missed visiting chapters, in person the most, and missed enjoying the delectable cuisine that each chapter provided. President Pyle reported that she planned to attend a few in-person chapter meetings this spring, while her term as president was still active.

### Introduction of International Guest-Bonnia Cook Fouts (Alpha), KSO 1<sup>st</sup> Vice President

**Dr. Lace Marie Brogden** (Regina), Saskatchewan, Canada, International 1<sup>st</sup> Vice-President. Dr. Brogden provided five fun facts about herself, before presenting "Society Update 2021" by Becky Sadowski, International President and The International Administrative Board, 2020-2022. She noted that the board chose their governing theme as, "The Will to Govern Well: Knowledge, Trust, and Nimbleness", based on a book authored by Glenn H. Tecker, and that their Strategic Plan was a roadmap, including SMART Goals, Knowledge, Nimbleness, Checkpoint, and Trust. She discussed DKGIEF (International Educators Foundation), which is now the ONE and only foundation within DKG; donations can be designated toward a specific area of need, but they are all under the DKGIEF umbrella. Dr. Brogden thanked the membership for all their great work and contributions, and invited members with a special presentation in mind, to join the International Speakers List, from which all conventions choose their speakers. President Beth commented that KSO had contributed to the "International Speakers Fund" in Lace's honor. A discussion followed about 2021's International Conferences and why costs were the same for virtual and in-person attendance? Lucy Riffle noted that Officer Training is in Atlanta versus one of the International Conferences. Past-president, Sue Story, sent virtual hugs to Lace, as they enjoyed a previous conference together.
